John Ferguson - President

John Ferguson is currently the Manager of Municipal Police Services for The City of Red Deer. In this role John is responsible for leading the staff that support the RCMP in Red Deer, and The City's Community Peace Officer Program. Prior to joining The City of Red Deer, John was a 35-year veteran of the RCMP, having retired as the Assistant Commissioner in charge of Criminal Operations for the Province of Alberta. John has an extensive policing background having worked in numerous detachments and specialized units throughout Manitoba, Nova Scotia and Alberta. His policing experiences are very broad as he has worked in small isolated communities with significant geographical areas of responsibility, to managing investigations that were national and international in scope.

John is dedicated to building trust and confidence in all the positions he has held, and focuses his efforts on community engagement and collaborative partnerships with community groups, and stakeholders.
